NDHRC increases & enhances grass roots interest & support for human rights issues by providing a variety of activities which include annual conferences with workshops and keynote speakers. NDHRC also fields questions from the state population regarding human rights complaints and providing referrals where appropriate.

NDHRC works to expand human rights laws & policies within systems and institutions by increasing citizen participation and power in human rights outreach, education, and enforcement. Activities included sponsoring legislation to amend the ND Human Rights statute to include sexual orientation, gender identity and gender expression.

NDHRC conducts live human rights workshops in communities across the state, concentrating on junior high and high school audiences, with each workshop tailored to local issues or interests. Each workshop is done in coordination with the local school staff and becomes part of the curriculum.
