During 2009, one newly constructed branch library opened in the San Jose Public Library System - the historic East San Jose Carnegie Branch. A special campaign was held for this branch which raised over \$45,000. The SJPLF also raised over \$200,000 in unrestricted gifts \$335,000 for other branches and programs within the San Jose Public Library system. Donor wall unveiling receptions were held for the three branches that opened in 2008 - Pearl Avenue, Joyce Ellington and Willow Glen, with over 300 donors attending the three events. In addition, a fundraising event for the East San Jose Carnegie Branch was held at Congresswoman Zoe Lofgren's home.
The Legacy San Jose - Alviso Youth Foundation provided funds to assist
