Line 4a. Film Production

Going into its eleventh year, UPF has now produced seven films, with several films in development. These range from traditional long-form historical documentaries for television, such as *Muhammad: Legacy of a Prophet* (2002), *Cities of Light: The Rise and Fall of Islamic Spain* (2005), and *Prince Among Slaves* (2006), to contemporary one hour bio-docs such as *On a Wing and a Prayer* (2007) and *Talking Through Walls* (2008) to its latest data-driven policy documentary *Inside Islam: What a Billion Muslims Really Think* (2009). All of these films have been broadcast locally and/or nationally on PBS. In 2008, UPF placed its first full-length film in theaters around the country, a stand up comedy performance movie called *Allah Made Funny* (2007). Each of these films has won one or more national awards, such as the Cine, Golden Globe, Golden Eagle, and Telly awards for the film, as well as numerous "craft" awards for best editing, musical score, writing, and direction, among others. In addition, UPF's films are used in new media outlets, including the World Wide Web, living room screenings, and a variety of social networking websites such as Facebook and YouTube. As media technology expands and changes, UPF continues to seek ways to reach, create and transform new audiences.

Line 4b. Education and Outreach

UPF's educational mission is carried out in several ways, most significantly through two of its major community outreach, education, and resource programs: *20,000 Dialogues* and *MOST*:

20,000 Dialogues

20,000 Dialogues is a nationwide initiative that uses film to facilitate informed conversations and public programs about Muslims and Islam. The program uses online marketing and partnerships with national organizations to engage teachers, students, community members, members of churches, synagogues, temples, and mosques, policymakers, government officials and the general public. These groups conduct small- and large-scale public programs using downloadable lesson plans, discussion guides and UPF films. More than 500 organizations, such as high schools, universities, libraries, museums, interfaith groups, religious establishments, the US State Department, mayor's offices, and YMCAs have partnered with UPF. Altogether an estimated 70,000 people have participated in nearly 10,000 events.

MOST

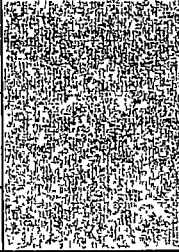
Standing for “Muslims on Screen and Television,” MOST is a project centered in Hollywood to provide the creative community there with a resource for accurate information about Islam and access to the Muslim community. As Muslim themes and characters appear more often in television and film, writers and producers face a complex challenge: presenting multidimensional characters and stories that transcend stereotypes. After two years of needs assessments among the Hollywood entertainment community, UPF, in partnership with the Saban Center for Middle East Policy at the Brookings Institution and the Gallup Organization and the Muslim West Facts Project, launched *Muslims on Screen and Television* (MOST) in 2009 to provide the Hollywood creative community with resources and accurate information on Muslims and regions with majority Muslim populations. The program, based at the University of Southern California’s School of Cinematic Arts, also engages thought leaders and the entertainment community in an on-going dialogue about the United States and the Muslim world. Through MOST, UPF aspires to positively influence films beyond those that UPF has the means to produce itself, expanding its reach into even more homes, communities and organizations where important decisions impacting understanding, peace and security are made.
