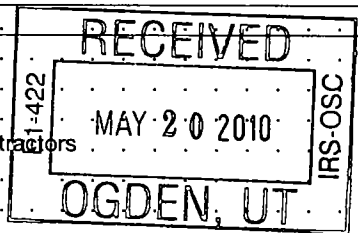

### **Form 990, part III**

#### **Organization's Primary Exempt Purpose**

Restoration Outreach Programs' purpose is to help marginalized children, teens and adults living in poverty on East Colfax in Aurora, Colorado. It pursues this purpose through two distinct programs – Prodigal Gatherings and Heart to Hand Resource Center.

Prodigal Gatherings creates safe places for children and teens living in poverty. Staff and volunteers serve as positive role models and develop redemptive friendships with children and teens through our Club House and Coffee House programs.

Heart to Hand Resource Center seeks to move its clients toward lives of self-sufficiency through the provision of job training services and classes, GED classes, counseling and life skill training. In addition, Heart to Hand operates a full food bank and offers several special outreaches of food and clothing throughout the year.
