Part II, Section C, line 17a, Facts and Circumstances Test:

The Billings Exchange Clubs Foundation for the Prevention of Child Abuse
(Organization) does not meet the 33 and 1/3% public support test for a
publicly supported organization under 509(a)(1). However, it has received
over 10% of its support from the general public and therefore believes it
qualifies under the facts and circumstances test as a publicly supported
organization. Below are the facts supporting its qualification:

Facts and Circumstances

Over 10% of the Organization's support comes from the general public.

The Organization has conducted various fundraisers (a raffle, a poker
tournament, dinner and an auction) in the past five years. The
Organization is constantly soliciting funds from the general public. The
solicitation of funds takes place at the weekly or semi-weekly meetings of
three Exchange Clubs (section 509(a) (4) service clubs) in Billings,
Montana. These bona fide methods of raising funds have been successful in
the previous 5 years.

Five public support factors

Approximately 6% of the Organization's support comes from investment
income. A significant portion of the original contributions which now
generate the investment income for the Organization did not come from one
individual or family.

The Organization does not receive a significant portion of its support
from one individual or family. Approximately 66% of the Organization's
support comes from one section 509(a) (4) service club which consists of
approximately 75 members, none of which has any type of control over the
service club now or in the future.

The board of directors, and control, of the Organization consists of 9 board members with terms of 3 years. The board members are appointed by three Exchange Clubs. The four officers of the Organization are elected by the board.

The Organization provides funds (\$7,273 in 2009 and \$9,900 in 2008) for other non-profit organizations in the Billings, Montana area which support the prevention of child abuse. Funds can not be used for any other purpose.

The three members of the Organization maintain their membership by contributing to the Organization at least 10% of the total funds donated each year from fund raising efforts of the member Exchange Clubs. The Organization is controlled by the three Exchange Clubs in Billings, Montana: The Downtown Exchange Club, (founding member in 2000) the Big Sky Exchange Club (joined in 2003) and the Heights Exchange Club (joined in 2004). In general the Organization believes it should not be treated as a publicly supported organization because of the above facts and circumstances. The three clubs will never be controlled by any individual or family.
