LANE COUNTY DUII VICTIM IMPACT PANEL (VIP) 2009

Form 990-EZ PART III – Statement of Program Service Accomplishments

The purpose of the Lane County DUII Victim Impact Panel (VIP) is to educate court-mandated offenders arrested for “driving under the influence of intoxicants” (DUII) about the impact their behavior has on other individuals and their community. Victims of drunk- driving accidents and family members (all volunteers), law enforcement personnel, hospital personnel, and others affected by an individual’s drunk driving are utilized to present the monthly panels to offenders.

In 2009, 2,583 offenders were referred to the program, of which 1,779 attended. They are required to listen to the volunteer speakers, watch video presentations, and learn about making better choices re: drinking and driving. Fees for the program were \$20 and were raised to \$30 in April, 2009. The revenue pays administrative expenses and allows the program to support other charitable organizations with like-minded goals.

Line #28: VIP donated \$14, 400 to Mothers Against Drunk Driving, Pacific Northwest Region, Eugene Affiliate, a 501(c)(3)organization.
