





a natural person of full age and a citizen of the United States of America, have voluntarily
and do hereby associate ourselves together for the purpose of forming a non-profit
corporation under the laws of the State of Idaho, Idaho Code, Title 30, Chapter 3, and we do
hereby certify, declare and adopt, and restate the following Articles of Incorporation.

I.

NAME OF CORPORATION





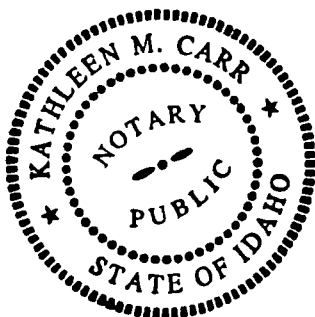
