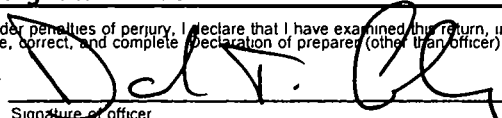
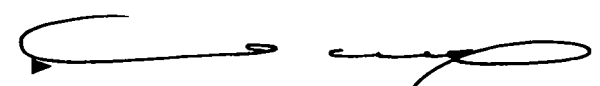

CONFLICTS OF INTEREST REVIEWS ARE HANDLED ON A CASE-BY-BASE BASIS, HOWEVER, EPIC'S POLICY IS THAT ACTIVITIES IMPACTED BY A CONFLICT OF INTEREST MUST BE COORDINATED AND MANAGED BY A NEUTRAL PARTY.
