

Part III Statement of Program Service Accomplishments

In 2009 Horse Warriors was featured on national TV in the ABC Primetime special "Wild Mustang Hearts." Students were filmed for 2 full days with a focus on the special bonds developed between upper level HW mentors and their younger Power Ponies students and horses.

In addition, HW extended its arts programming by adding Power Ponies and Mighty Mustangs "Art Days" over the winter. Younger students in the parenting programs attended half-day collaborative art workshops. Some of them included projects with their parents, and some consisted of individual projects in which students were assisted by their summertime mentors.

Parent discussion groups were also introduced in an effort to help support more of the parents year round by giving them opportunities to share challenges and hear advice from their peers.

In 2009 the Horses of the Goddess workshop shifted gears to become a professional training provider for therapists and instructors interested in learning the about the field of equine facilitated mental health and learning. This was due to a persistent demand from the field of equine assisted activities to provide skilled training for the specific needs of clients with mental health issues.

The executive director was honored by Soroptimist of Jackson Hole as the recipient of their "Women Helping Women" award for her many years of helping empower women and girls through the Horse Warriors program.
