Ecologically sound management for off-road vehicles (ORVs):

We have designed methods to both monitor and make ORV management decisions based on meeting
ecological health goals and the needs of quiet recreation users. Reviewed by the science community, ORV
management best management practices, of which we are a major author, have been distributed to
most National Forest offices for their use. As a result, the Forest Service is considering making them a part of
their national decision process. Our partners continue to use these best management practices with our
technical and scientific support in a number of decisions in the west. A copy can be downloaded from our

Resilient habitat, preparing our wild places for climate change: Riparian areas
which cover a small percent of our region, are vital to both wildlife and people, yet most are
impacted and even more so during a drought. Our precedent setting riparian assessment method looks at habitat he:
from the perspective of wildlife. We have published our riparian assessment method and published a peer reviewed
scientific journal article about this. For the past several years, we have been working with communities to help them
gather long term data on sagesteppe habitat health. During 2009, we applied these data to demonstrate
ecologically based range management. We presented our study and work in scientific symposiums and plan
to publish the results in peer reviewed journals. This range management work has possible far reaching
benefits to identify and restore habitat resilience for western rangelands.

Our scientists unravel cryptic government data and provide independent analysis (including GIS) to
help our numerous conservation partners apply science in their work. We have approximately forty partners that we

hunters, anglers, government agencies, universities, and more.
