Housing Counseling: Through the contracts with non-profit organizations providing free housing counseling, CNYCN connects homeowners with one-on-one counseling services to save their homes or negotiate a sustainable solution to their housing dilemma. Dedicated counselors and support staff work closely with the homeowner to develop a budget, assess mortgage documentation, negotiate with lenders and servicers and assist the homeowner through one of the most stressful events of their lives. The housing counseling is not simply an intake or triage, but is intensive one-on-one assistance to evaluate the homeowner's financial position and determine strategy for negotiation.

The Center for New York City Neighborhoods, Inc. (CNYCN) was created to address the local repercussions of the national foreclosure crisis. Through comprehensive, citywide programming that includes legal services, housing counseling and consumer education, CNYCN pursues multiple strategies to assist those at risk of losing their homes to foreclosure - both homeowners and renters alike. CNYCN seeks to support distressed homeowners to retain their equity and preserve New York City neighborhoods by limiting the negative impacts of foreclosure, property flipping and abandonment.

Legal Services: Individual sessions with legal services attorneys make a huge difference in lives of homeowners and their families. The legal advice that homeowners receive may include advice and counsel, representation in court and pro se assistance. The legal services lawyers are also on the cutting edge of advocacy to improve the New York mandatory settlement conferences. They have worked on a pilot in the Queens courthouse prior to the implementation of the new mandatory conferences, and now are dispersed throughout every courthouse in New York City, holding clinics and triaging cases in the courts. The work that attorneys do for homeowners facing foreclosure provides critical leverage to save homes. The new legal professionals that our funding and coordination support are able to advise and represent homeowners facing court proceedings, and they are also particularly skilled at assisting pro se individuals file answers in their cases. Legal services offices also have the ability to affirmatively prosecute claims where clients have been defrauded.

Program Partners: CNYCN has three Program Partners: organizations at the forefront of housing counseling, legal services, and consumer education and protection in NYC.

CNYCN's Program Partners are: Legal Services for New York City (LSNYC), Neighborhood Housing Services of New York City (NHSNYC), and the Neighborhood Economic Development Advocacy Project (NEDAP). The Program Partners act as special consultants to our organization, and provide trainings and direct technical assistance to our Network Partners. Our Program Partners each use a multi-stage process to advance support for our network. They begin by conducting an assessment of each of the Network Partners, which starts with a site visit to meet the service providers and determine their knowledge, resources and operational infrastructure.

From these visits they create a capacity report, which they share with CNYCN to encourage the development of suitable training and technical assistance. Based on these findings, the Program Partners build a monthly training calendar, with particular trainings requiring mandatory attendance. Between monthly trainings, Program Partners respond to phone and email requests for guidance in resolving particularly complex cases. These one-on-one technical assistance sessions are tracked to determine trends, which further informs the planning of the training regime. Through this iterative process, we stay abreast of how our service providers are adapting, and ensure that the network is ready and able to meet the new day's challenges.

Training and Capacity Building: CNYCN's Program Partners conduct monthly trainings that focus on various topics aimed at increasing capacity and maintaining best practices throughout the network of non-profit service providers. Trainings, which are also made available to non-profit organizations outside of CNYCN's network, tackle topics such as credit, income and assets; loss mitigation options, including forbearance, loan modifications, payment plans, deed-in-lieu and short sales; and changing bankruptcy laws.
