The Medical Center provides an allowance for doubtful accounts based upon a review of the outstanding receivables, historical collection information and existing economic conditions. As a service to the patient, the Medical Center bills third-party payers directly and bills the patient when the patient's liability is determined. Patient accounts receivable are due in full when billed. Accounts are considered delinquent and subsequently written off as bad debts based on individual credit evaluation and specific circumstances of the account. Our costing methodology used to determine bad debt expense uses a ratio of patient care costs to charges.

Our costing methodology used to determine medicare allowable costs uses a ratio of patient care costs to charges

Our charity care policy outlines steps for financial counselors to follow to identify patients eligible for charity care and steps to collect information. The policy also describes the application form to be completed by the patient, the review process by a financial counselor, patient follow up, and the write off of patient charges to charity care if possible.
