Donor Alliance will serve all who need transplantation by maximizing the number of available organs and tissues with a commitment to innovations, new technology, and influencing policy Donor Alliance will be a center of excellence with a highly engaged and competent staff Donor Alliance is one of 58 federally designated, non-profit organ procurement organizations serving Colorado and most of Wyoming Additionally, it is a member of Association of Organ Procurement Organizations (AOPPO) and American Association of Tissue Banks (AATB) accredited

Clinical Activities for Organ and Tissue Donation As a recognized leader in facilitating the donation and recovery of transplantable organs and tissues, Donor Alliance's mission is to save lives through organ and tissue donation and transplantation With more than 106,000 people awaiting transplantation throughout the country and close to 2,000 in the state of Colorado, Donor Alliance is dedicated and focused on recovering as many organs as possible for those awaiting transplantation In order to fulfill this great responsibility, Donor Alliance establishes and maintains strong relationships with donor hospitals helping the hospital maximize their donation opportunities Donor Alliance employs effective family approach and recovery programs in more than 100 hospitals Additionally, Donor Alliance saves and heals lives by facilitating the recovery of tissue for those needing human tissue allografts Donor Alliance was able to maintain its strong results in 2009 helping facilitate the donation and recovery of 368 organ transplants from 115 donors in 2009 Organs transplanted increased from 356 in 2008 Tissue saw a slight decrease from 940 donors in 2008 to 894 donors in 2009 due to a narrowing of medical criteria for donation The organization reported a 91 percent authorization rate, rate at which donor families say yes to donation when approached Nearly 50 percent of the 115 organ donors and 56 percent of the 894 tissue donors in 2009 were listed on either the Colorado or Wyoming State Donor Registries Additionally, Colorado ranked first in the nation for its 64 percent donor designation rate - the rate at which people say yes at the Division of Motor Vehicles - at the close of 2009 Donor Alliance maintained in-house hospital coordinator positions at key hospitals to improve customer service, donation outcomes and interactions with donor hospital staff Nine Donor Alliance hospitals received Medals of Honor from U S Department of Health and Human Services, Health Resources and Services Administration The National Organ Donation Collaborative to recognize recovery and transplant rates that lead the nation Colorado boasted the nation's highest-performing state donor registry in 2009, 64% of licensed drivers saying yes at the DMV Wyoming finished fourth in state donor registry performance for 2009, 55% of licensed drivers saying yes at the DMV Donor Alliance continued the process of building a free-standing operating room facility This facility will assist Donor Alliance in holding down organ and tissue recovery cost

Community Relations and Public Education A large barrier to consent for donation is education Many myths and misconceptions about organ and tissue donation persist, and stop people from becoming a donor Donor Alliance works directly with community leaders and gatekeepers to provide information, to answer questions, listen to concerns and ultimately find ways to encourage new donors to say "YES" Donor Alliance inspires the public to register as organ and tissue donors through community partnerships, public outreach and education campaigns throughout its donation service area Colorado's donor designation rate (the percentage of people who enroll as registered donors when obtaining or renewing their driver's license) was 64 percent at the close of 2009 - the highest performing state donor registry in the nation Wyoming, ranked fourth highest with a 55 percent donor designation rate Donor Alliance has a three-person community and public relations staff and works with a full-service public relations agency that disseminates messages through the media, community leaders and grassroots community groups The 'Advocates for Life' volunteer program boasts close to 200 active volunteers who give presentations to encourage organ and tissue donation Presentations are made to various community groups (ex Diabetes Expo), churches, civic organizations and hospitals They are recognized each year with a ceremony to honor their commitment In 2009, Donor Alliance sponsored two floragraps (floral images depicting a loved one) on the 2010 Tournament of Roses Donate Life Float for families in Denver, Colorado and Casper, Wyoming Partnering with Olinger Mortuaries and Cemeteries, we conducted a decorating ceremony for these families on December 15, 2009 Media was present The Donor Family Tribute is an annual event where all donor families from a two-year time span are recognized for their loved ones gifts During the event each family is given a medallion, special donor family pin and participate in a release of balloons that signifies how life carries on through donation Donor Alliance's signature event, the Donor Dash, is held annually as a 5K for runners, walkers and the entire family to honor the lives of organ and tissue donors, celebrate the lives of organ and tissue recipients and recognize the lives of those waiting for a lifesaving transplant This is recognized as the largest organ and tissue donation awareness event in the state In 2009, there were a record 3,100 participants For three consecutive years the participation growth rate has increased by 25%, annually Donor Alliance runs a program with local businesses called the Workplace Partnership for Life This program allows educational literature and donation consent information to be distributed through paychecks and other employee communications vehicles

The CEO is responsible for completing an annual performance appraisal on the CFO and COO based on pre-determined goals and competencies. After all the information is presented, the executive compensation committee will approve compensation levels for the next year based on the performance appraisals and recommendations from the independent consulting firm. Key employees are evaluated annually by executive leadership (CEO, CFO and COO) and salary increases are based on their performance, within prescribed salary ranges. Salary ranges are reviewed with RSM McGladrey, an independent third party consultant, and have been determined to be reasonable compared to organizations of similar size and scope of responsibility. Performance is based on pre-determined goals and competencies.
