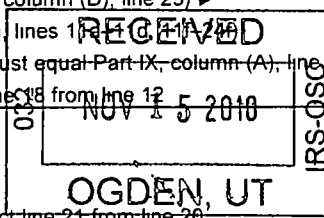

On January 9th 2007 Southwest Conservation Corps (SWCC) and The Durango Adult Education Center (DAEC) formed a nonprofit corporation, Southwest Institute for Education and Conservation (SIEC), to provide office space and facilities to educational agencies and nonprofit

The corporation purchased a building at 701 Camino Del Rio, Durango, Colorado on February 28, 2007 for \$ 4,875,000. The building was financed by a bridge loan of \$4,500,000 from the First National Bank of Durango (FNBD). Southwest Conservation Corps and the Durango Adult Education Center each guaranteed the note on the building.

On January 4, 2008 SIEC obtained permanent financing through the U. S. Department of Agriculture Rural Development Community Facilities program and paid off the First National Bank of Durango bridge loan. The permanent financing includes a \$4,000,000 direct loan through USDA and an \$800,000 USDA-guaranteed loan through First National Bank of Durango. SIEC is recognized as an investment on the books of Southwest Conservation Corps at a value equal to 50 percent of the equity of SIEC. The fair market value of a 50 percent ownership in SIEC as of December 31, 2009 is \$94,975.

On June 30, 2008, SIEC completed a New Markets Tax Credit (NMTC) transaction. The NMTC Program permits taxpayers to receive a credit against federal income taxes for making qualified equity investments in designated Community Development Entities (CDEs). The credit provided to the investor totals 39 percent of the cost of the investment and is claimed over a 7-year period.

SWCC and DAEC formed a limited liability company, The Commons Leveraged Lender LLC (TCLLLLC), for the purpose of participating in the New Markets Tax Credit transaction. SWCC and DAEC each invested \$938,317 in The Commons Leveraged Lender LLC in 2008.

The Commons Leveraged Lender LLC made an equity investment into TC-SIEC QEI, LLC, which then made an investment into NDC New Markets Investments XXXII, LLC, a Community Development Entity (CDE). The CDE made

a loan to SIEC, providing SIEC with resources to purchase a new HVAC system. At the closing of the transaction, SIEC had two new promissory notes totaling \$2,646,819 while The Commons Leveraged Lender LLC had a loan receivable of \$1,953,060. The New Markets Tax Credit structure will stay in place for 7 years after which time its major components will disband. The fair market value of a 50 percent ownership in TCLLLLC as of December 31, 2009 is \$947,430.
