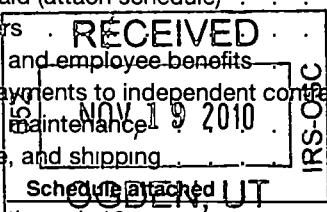

Explanation of line 20, Part 1, page 1:

The Form 990-EZ for the year 2008 was prepared and filed before the Review of the 2008 Financial statements was completed by the Independent Accountants for RMLEIF. In the process of that review, the CPA's doing the work found that an error had been made by the Treasurer in the accumulation of the value of the securities included in the investment portfolio and the calculation of the value of the RMLEIF amount to be received in the future from a Trust after both beneficiaries pass on. The total of these two adjustments increased the fund balance at 12/31/08 by \$22,023.
