They use these fees to pay expenses such as referees, officials, umpires, games fields, gym space for games, as well as their administrative fees to schedules thousands of games per year.

Field Use/Setup - These expenses are incurred for renting the fields from local schools, recreation centers, parks and recreation districts and cities. Setup includes costs incurred for chalking the fields for baseball, and lacrosse, burning lines in the fields for football, setting down markers and yardage pylons for football, and any painting of lines required by the leagues.

Equipment - This expense is for equipment used to further the kids enjoyment of the sport. It includes bases, chalk, paint, tackling dummies, batting helmets, baseballs, lacrosse goals, footballs, basketballs, volleyballs, nets, medical kits, and anything else required to play these sports. The kids are responsible for their own uniforms and sport specific equipment.
