ZACH'S PLACE. THIS PROGRAM, THE ONLY ONE OF ITS KIND IN THE PIKES PEAK REGION, HISTORICALLY PROVIDED RESPIRE AND CHILD CARE PROGRAMS ALONG WITH SCHOOL PLACEMENTS AND COMMUNITY MENTORING PROGRAMS. IN PRIOR YEARS, WE PROVIDED ACADEMIC PROGRAMMING FOR CHILDREN FROM SCHOOL DISTRICT #11. IN 2007 SCHOOL DISTRICT #11 CREATED THEIR OWN IN-HOUSE PROGRAMS FOR CHILDREN WITH DISABILITIES AND OUR SCHOOL PLACEMENT PROGRAM WAS NO LONGER NEEDED. IN LATE 2007 AND 2008, THE AGENCY INITIATED A MONTHLY "GIFT OF TIME" OPPORTUNITY FOR PARENTS TO WHO HAVE NEVER HAD RESPIRE CARE TO TRY RESPIRE CARE ON A WEEKEND DAY FOR FREE. THE CLIENTELE HAVE SUCH DIAGNOSIS AS AUTISM, DOWN'S SYNDROME, ANGELMAN'S SYNDROME AND SEIZURE DISORDERS.
