## **990 PROGRAM SUMMARY REPORT – 2009 RGCDC**

### **SOUTH VALLEY ECONOMIC DEVELOPMENT CENTER (SVEDC)**

The South Valley Economic Development Center (SVEDC), a project of RGCDC, has increased to about 60% capacity kitchen use and resident businesses at nearly full capacity. 2009 activity includes over 40 kitchen users, 12 resident businesses, and 3 partnering private, non-profit organizations. We also participated in several on-going community-serving and charitable efforts from our state-of-the-art commercial kitchen. In five years of operation, the SVEDC has helped to develop over 90 businesses in Bernalillo County. In 2009, the program provided business orientations for over 200 new businesses, and has helped nearly 50 food-based businesses improve their operations. Grant funding sources include the State of New Mexico, Whole Foods, Bank of America, Wells Fargo, and Forest City Covington, and in-kind assistance from Bernalillo County. The SVEDC has also provided contract assistance in feasibility studies for Cuba, NM. The SVEDC continues to partner with many of the other nonprofit organizations in Bernalillo County to bring substantial training opportunities to small businesses in the South Valley. As a result of these trainings, the accountability structure, and the community atmosphere developed at the SVEDC, the Center has produced millions of dollars in payroll for residents of Bernalillo County.

**Mesa del Sol** continued to support the Rio Grande Growers Association (RGGA) to encourage the collaborative of local landscape growers. It is projected that RGGA will supply landscape plants locally reducing the need to ship in plants from out of state, increasing water efficiency and plant survivability through utilization of more native plant species.

**SOUTH VALLEY PARTNERS FOR ENVIRONMENTAL JUSTICE (NIEHS grant):** In partnership with Bernalillo County Environmental Health and the UNM Department of Community and Family Health began working on issues in environmental justice, July, 2001 to present, with funding from the USNIH-NIEHS. RGCDC became the fiscal agent in 2005 contracting with UNM and Bernalillo County and is the community partner working to identify land-use and environmental health risks as well as providing community based participatory research and community outreach in the unincorporated South Valley of Bernalillo County. Activities fully continued until August, 2009.

### **Specific Aim #1: To research the development of a community-based model that integrated the community in land use planning and decision-making.**

**The South Valley Pathways Collaborative (SVPC)**

SVPC consists of PB&J Family Services, Casa de Salud, La Plazita Institute, and South Valley Economic Development Center (SVEDC) program of the Rio Grande Community Development Corporation (RGCDC). The purpose is to: connect underserved county residents with health care and support systems and assist them as they navigate through it; coordinate services to achieve positive individual health outcomes; and assuring collaborative planning and improvement of health policies and the local health system for the residents of the South Valley.

The lower socio-economic status of residents in the unincorporated South Valley is one of the main risk factors for many adverse health effects. Forty-six percent of the population is living under 185% of the federal poverty level (FPL) with income inequality even greater among the area's recent immigrant population. In response, SVPC initiated a neighborhood-based Pathways project within the County wide Pathways Program. The SVP Collaborative placed Community Health Navigators (CHNs) as promotores at each partner site.

The SVP Collaborative established the Pathways model in the unincorporated South Valley, zip code areas 87105 and 87121. In contrast to much of the surrounding city, the South Valley is made up of semi-urban agricultural land, historic villages, new development, and low-income housing. The area is classified as rural by the Federal CMS Rural Health Clinics program.

**JAZZ for Health/Casa de Salud PARTNERSHIP:** RGCDC property at 1608 Isleta Blvd SW RGCDC was leased to JAZZ for Health January, 2007, and has continued through 2009. The 1608 facility is utilized by JAZZ for Health to provide affordable medical and health care and traditional healing services. This effort is providing services to South Valley and ABQ Metro residents who are uninsured, underserved and/or hold beliefs regarding using traditional healthcare practices.

**PARTNERSHIPS WITH COMMUNITY ORGANIZATIONS:** The provision of organizational support including fiscal agent services, continued with Dragon Farm/Project Renaissance and Project Sunrise, Mountain View Community Action, KooKooEE Community Education Association, JAZZ for Health, was initiated in 2002 and continues to present. Others include: **Place Matters** from the joint Center for Political and Economic Studies to prepare a solid , evidence-based foundation for understanding and addressing multiple social determinates of health; SW Pajarito Mesa Community Project to utilize resources from **Catholic Campaign for Human Development** to develop water and related resources for households on Pajarito Mesa.
