The Kane and Two Mile Ranch Program works with federal land management agencies to explore new and innovative ways to improve land management through public-private partnerships In 2009 several graduate students and one post-doctoral student from Northern Arizona University completed research projects related to livestock and land management issues The Trust played a leadership role in Kaibab Vermilion Cliffs Heritage Alliance, which led to several square miles of Vermilion Cliffs National Monument being surveyed for archaeological sites and the co-sponsoring of an archaeological field school The Trust also continued to graze livestock in as ecologically sustainable way as possible

The Colorado River in Grand Canyon Program continued to advocate for improved management of Glen Canyon Dam to protect the natural and cultural resources downstream of the dam in Grand Canyon National Park The Trust successfully advocated for a high-flow release to help restore beaches, completed an economic study on the cost of doing seasonally adjusted steady flows to retain beaches and the habitat associated with them that benefits the endangered humpback chub and other resources, and secured a decision in federal court that the Fish and Wildlife Service issue a revised Biological Opinion related to the humpback chub

The Volunteer Program completed numerous conservation, restoration, research, and infrastructure projects on the Kane and Two Mile Ranches, in Grand Canyon National Park, on Native American lands, and on U S Forest Service lands in southern Utah About 400 volunteers donated more than 14,000 hours of their time during 2009

AIR AND ENERGY PROGRAM promotes the installation of renewable energy projects, particularly on Native American lands, advocates for the transition from fossil-fuel electricity generation to less carbon intensive technologies, strives to reduce air pollution from existing large sources, and ensures that new pollution sources are fully in compliance with the Clean Air Act ARIZONA FORESTS PROGRAM focuses primarily on the development and implementation of the Four Forests Restoration Initiative, which seeks to restore about 750,000 acres of forest in northern Arizona , as well as working on forest health issues on the Kaibab Plateau on the North Rim of the Grand Canyon UTAH FORESTS PROGRAM seeks the reintroduction of beaver to their natural habitat in southern Utah forests to help restore degraded stream systems, attempts to reduce the impacts of livestock grazing in fragile riparian areas, and is working to establish reference areas to be used as baselines for more accurately informed management decisions by land management agencies GRAND CANYON PROGRAM advocates for protecting the Grand Canyon From uranium development and is working to finalize rules for air tour over flights that will protect natural quiet in the canyon NATIVE AMERICA PROGRAM is partnering with representatives of 10 Native American tribes to develop a suite of conservation projects that will be chosen and implemented by tribal residents, NGOs, and tribal governments, as well as advocating for the establishment and funding for a green economy commission that will focus on green jobs on the Navajo Nation
