Advocated for greater protections on and improved management of public lands, including national forest, national park, national conservation areas, national wildlife refuge and state and regional planning units. The program promoted the strongest conservation decisions possible within agency planning processes, while engaging members, partners, volunteers and community leaders in advocating for policy reforms that enhance species diversity and habitat protection. Began overarching climate change adaption work to build a network of regional partners committed to improving landscape resilience through adaptive management and monitoring.
