Statement of Program Accomplishments for 2009

ADOPT A FAMILY (\$3,060)

This fund provides assistance to families in need through gift cards for clothing, transportation, food and other life necessities. Volunteers can also adopt a health center family in need and offer assistance. Over 124 individuals were helped in 2009.

ASTHMA EDUCATION PROGRAM (\$42,563)

The El Rio Inner-City Asthma Intervention Program targets children between the ages of 3-18 suffering from moderate to severe asthma who live in medically underserved areas. The Asthma Intervention program provides life-saving medication and equipment, as well as preventive education, for asthmatic children from low-income families. The program has helped bring about a 50 percent reduction in emergency room visits to two Tucson hospitals and a 20 percent reduction in missed school days. Donations pay for supplies, including medical equipment and supplies to control allergens (i.e peak flow meters, HEPA vacuum cleaners, mattress/pillow covers); medications, training for parents and the development and monitoring of an individualized asthma action plan for each child. Over 100 children were helped in 2009

CHILDREN'S IMMUNIZATION PROGRAM (\$18,336)

El Rio coordinates and runs free weekly walk-in immunization clinics at three clinic locations in Tucson and in 2009 we held four immunization clinics throughout the Tucson community and immunized 1404 children at those community events.

Our Children's Immunization Clinic offers an innovative and accessible approach to keeping our children up to date on their shots.

- 1) Free walk-in immunization clinics (no appointment necessary) at three locations throughout town & several outreach events each year that provide free immunizations.
- 2) A tracking system to keep tabs on children in need of shots. Parents/ guardians are regularly called by El Rio to remind them to bring in their children for the required immunizations.
- 3) A bi-lingual medical assistant that educates our many Hispanic clients to understand the importance of immunizations as well as help make the children more comfortable with the process. The medical assistant is also the person that uses the tracking system and calls the parents. 13,848 Children were immunized in 2009.

DENTAL PARTNERSHIP PROGRAM (\$12,327)

El Rio operates the largest non-profit dental clinic in the State of Arizona, with treatment visits in excess of 35,000 people seen per year. This program assists qualified patients that do not have the resources available for preventative dental care. In 2009 over 50 patients received dental services in this program.

DIABETES PREVENTION PROGRAM (\$101,590)

The Diabetes Prevention Program is an community-based educational program aimed at reaching impoverished people at risk for diabetes. The program helps participants learn how to prevent or delay the onset of this disease. The free classes are offered as a series of sessions and give participants the information, incentive and encouragement needed to deal with this pervasive disease. In 2009 105 participants attended the classes.

THE HEALTH EDUCATION PROJECT (\$6,044)

The Health Education Project recruits, trains and places volunteers to provide health, wellness and life skill classes to people who are homeless or at-risk of being homeless. We have over 40 prepared curricula that are taught to the people staying at homeless or domestic violence centers, substance abuse rehabilitation centers, and correctional institutions. Over 4000 participants attended the classes in 2009.

CARE FOR THE HOMELESS (\$1,227)

El Rio's clinic offers people in our community who are homeless a safe place where they can receive primary health care, case management, advocacy and behavioral health services. El Rio also provides eyeglass vouchers and bus passes for Tucson's homeless population. Last year 20 individuals received glasses and bus passes

PHARMACY BASED DIABETES MANAGEMENT PROGRAM (\$379,845)

This award winning program utilizes pharmacists that are certified and licensed to prescribe medications and practice as specialists in the Disease Management Program. This specialized role of the clinical pharmacist allows them to regulate specific aspects of a patient's treatment and allows for a higher intensity of monitoring of the patient's progress. Annually, 1,200 - 1,500 patients with Type 2 diabetes receive care through this program. Through this innovative approach patients have dramatically lowered their blood sugar, blood pressure, and "bad" cholesterol readings. El Rio currently has clinical pharmacists at four locations including Pascua Yaqui Clinic.

REACH OUT AND READ CHILDREN'S LITERACY PROGRAM (\$23,196)

Reach Out and Read is a program that builds on the special relationship between doctors and the parents of young children to support children's language and literacy development. At well-child visits, from 6 months to 5 years, El Rio doctors and nurses provide information about the importance of reading aloud and give new, developmentally appropriate books to the children to take home. Over 7,000 books have distributed through this program.

SCHOOL BASED CLINICS (\$37,500)

El Rio school based clinics service low-income families in the Sunnyside Unified School District (SUSD). The program provides on-site medical care at schools in SUSD.

TEENAGE PARENT PROGRAM (\$3,750)

The Teenage Parent Program also serves students in SUSD. In 2009 services were provided to 272 pregnant, parenting and at-risk students and 7 staff at 4 different schools. Services included case-finding, health assessment, clinical evaluation of health problems, health education, and case management.

VENTANILLA DE SALUD (\$30,752)

The Ventanilla de Salud (VDS) program is a unique partnership between the US-Mexican Border Health Commission, Mexican Consulate and local Community Health Centers. VDS is staffed by a Community Health Care Advisor who provides critical health prevention information.

WELLNESS PROGRAMS (\$100,531)

El Rio's Women's Wellness Programs are collaborative efforts with American Cancer Society and Susan G. Komen for the Cure of Southern Arizona. Some of the services offered through these wellness models include: classes for the Latina breast cancer survivors, help with annual mammography screenings and education on breast health.
