

This organization planned to support a new non-profit at the end of 2008 and gave a donation to the new Celtic arts group. Shortly after that decision, the new decision was made to keep MCCA intact and the funds that had been transferred to the new organization came back under the MCCA account. During this decision making time, support and dues were collected from individuals and families interested in learning Celtic dancing. During 2009 these funds were added to the MCCA account in the amount of \$1866.18. Of these funds, \$1200.00 came from MCCA in 2008 and went back into the MCCA account in 2009.
