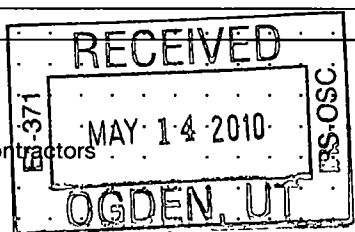



Explanation of Significant New Activities Not Previously Reported (Part V, Question 33)

In 2009, to help increase Philanthropy on Martha's Vineyard, we opened a Grant Writing and Research Center, bringing important free resources to the island that were previously only available by traveling to Boston. The Center offers the research databases of the Foundation Center and Associated Grant makers of New England as well as other resources. We also trained 15 people to assist non-profits with their grant work and held a 3 part grant writing and research workshop which was attended by 44 people. In our first 9 months of operation over 50 people used the center and 825 searches of the Foundation Center database were made.

Although this is a new program, it is completely consistent with our mission to increase Philanthropy on Martha's Vineyard and our strategy of building the management capacity of island non-profit organizations.
