INTERNATIONAL COMMUNITY HEALTH SERVICES ("ICHS") IS A COMMUNITY-BASED HEALTH CARE CENTER COMMITTED TO PROVIDING CULTURALLY AND LINGUISTICALLY APPROPRIATE HEALTH SERVICES TO IMPROVE THE HEALTH OF ASIAN PACIFIC ISLANDER AND OTHER COMMUNITIES. ICHS ALSO PROVIDES CHARITY CARE TO PATIENTS WHO MEET CERTAIN CRITERIA UNDER THE ORGANIZATION'S POLICY WITHOUT CHARGE OR AT AMOUNTS LESS THAN THE ORGANIZATION'S ESTABLISHED RATES. A MULTI-ETHNIC HEALTH CARE TEAM APPROACH AND A COMBINATION OF FUNDING SOURCES ENABLES ICHS TO PROVIDE AFFORDABLE COMPREHENSIVE HEALTH CARE WHICH ADDRESSES THE GAPS AND BARRIERS THAT PREVENT THE LOW-INCOME, NON-ENGLISH SPEAKING, ASIAN/PACIFIC ISLANDER POPULATION FROM AVAILING THEMSELVES OF ADEQUATE HEALTH SERVICES. ALL PATIENTS ARE REQUESTED TO PAY A MINIMUM FEE FOR EACH VISIT, HOWEVER, NO PATIENT IS DENIED SERVICES BECAUSE OF AN INABILITY TO PAY. DURING THE YEAR ENDED DECEMBER 31, 2009 ICHS PROVIDED \$1,437,636 OF CHARITY CARE SERVICES UNDER THIS POLICY.
