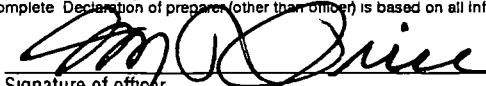

**Fifth Amendment to Amended and Restated Bylaws  
Dated January 21, 2005  
of  
Pilchuck Glass School**

**Adopted on January 30, 2009**

There shall be a new Section 2.8 which reads in its entirety as follows:

Section 2.8 – Trustees Emeriti. The Board may honor former Trustees who have provided extraordinary and unparalleled service and commitment to Pilchuck by inviting them to become Trustees Emeriti. The Trusteeship Committee shall establish the specific nomination criteria and nominate Trustee Emeritus/Emerita candidates for election by the Board. A Trustee Emeritus/Emerita shall serve for his or her lifetime or until his or her earlier resignation. Only for exceptional cause may the Board elect to revoke a Trustee Emeritus/Emerita designation. Trustees Emeriti may attend Board meetings (other than during executive session) and Committee meetings (other than the Executive Committee) and may be appointed to serve as members of any Committee other than the Executive Committee. Notwithstanding the foregoing, the designation of Trustee Emeritus/Emerita is an honorary position and shall not grant the status of Trustee for purposes of these Bylaws.

**Sixth Amendment to Amended and Restated Bylaws  
Dated January 21, 2005

**Adopted on July 31, 2009**

**I.**

There is hereby a new Section 3.6 which shall read in its entirety as follows:

Section 3.6 – Quorum. For all business not specifically listed in Section 24.03.115 of the Revised Code of Washington at the time of a particular meeting as being non-delegable to a committee, forty percent (40%) of the voting Trustees shall constitute a quorum for the transaction of such business. For all business specifically listed in Section 24.30.115 of the Revised Code of Washington at the time of a particular meeting as being non-delegable to a committee, a majority of the entire Board shall constitute a quorum for the transaction of such business. Each Trustee, other than the non-voting ex-officio Trustee described in Section 6.3, shall have one vote. At any meeting of the Board at which the applicable quorum is present, subject to the limitations in this Section, the applicable business may be transacted and the board may exercise all of its powers. The act of the majority of the voting Trustees present at a meeting at which there is an applicable quorum shall be the act of the Board as to the correspondingly applicable type of business unless the act of a greater number is required by law, by the Articles of Incorporation, or by these Bylaws. The Board shall adopt procedures for establishing a quorum through participation by means of conference telephone or other communications technology.
