Consejo ensures consumers are in full control of every aspect of their lives Our Behavioral and Mental Health Services assist clients by identifying concerns and problem areas in their lives that need change We also support exploring possible changes to propel wellness and recovery by making one change at a time At Consejo, our Psychiatric staff includes Board Certified Psychiatrists, Adult Psychiatric Nurse Practitioners, members of the American Psychiatric Association and the American Academy of Child and Adolescent Psychiatry Psychiatric services include prevention, assessment, diagnosis, treatment, medication management, and rehabilitation of mental illness such as clinical depression, bipolar disorder, schizophrenia, and anxiety Consejo's Adult Geriatric Day Support serves elders and people living with disabilities Services include developing independent living skills, physical and emotional health, nutrition and money management Consejo's services assist clients in building new capacity, improving socialization skills and developing successful coping strategies Consejo has an innovative, one-stop recovery program for adults who are suffering from chronic depression and/or living with mental illness Salud Integral (Integral Health) provides a wide range of regular, structured, therapeutic and recreational activities including nutritional lunches and transportation Salud Integral increases productivity and enhances personal fulfillment in a safe, unrestrictive environment Consejo's Natural Health Services Program helps clients who do not respond well to western medicine and favor alternative treatment Clients access acupuncture, Chinese and herbal medicine These healing arts work effectively for clients accustomed to natural healers and folk medicine Our clinic is staffed by clinicians from Consejo and John Bastyr University of Natural Health Sciences The program is unique because it is the only bilingual/bicultural Natural Health Services in King County and Washington State

Consejo's Substance Abuse and Chemical Dependency Treatment Program is an award-winning service that includes outreach and engagement, substance abuse prevention, drug and alcohol outpatient treatment, intensive outpatient treatment, recovery services as well as peer support services Participants also receive life-skills training, leadership skills development, nutrition counseling, transportation services and a wide range of therapeutic activities aimed at promoting sobriety and increasing functionality of all enrollees Every staff member is both bilingual and bicultural and a chemical dependency professional Consejo's Adult Substance Abuse and Chemical Dependency Treatment is a twelve-month program including individual counseling, ongoing group therapy as well as addiction education, relapse prevention, urinalysis, blood pathogen testing, case management services, family counseling, access to AA/NA/ALANON meetings, referrals to medical services, vocational rehabilitation and employment services In addition to the services provided by our twelve-month outpatient program, Consejo offers an intensive, 24-month treatment program that includes behavior modification designed to address a client's resistance to treatment, risk levels, potential for relapse, cravings, triggers, employability, legal advocacy and family reunification services Many elusive cultural factors contribute to a significantly high incidence of substance abuse among Latinos, especially males Consejo's ADIS addresses these issues directly by providing education in Spanish related to relapse prevention and resources in the sobriety community Consejo's ADIS is designed to be an educational intervention and is best suited for those who do not meet criteria for treatment Consejo's Consumer Awareness Program helps individuals stop shoplifting by offering comprehensive education in a group setting This service is a prevention tool aimed at minimizing re-offenses through personal disclosure and testimonies using confidential resources for individuals who have a shop-lifting problem

Consejo's Domestic Violence Program provides quality intervention, prevention and outreach services for monolingual Latina survivors of domestic violence and sexual assault Additionally, Consejo also offers community education and outreach to ensure battered Latinas receive relevant assistance when they turn to social networks for support All of Consejo's domestic violence services focus on safety planning and on empowerment of the client through reinforcing the client's autonomy and self-determination The more information a survivor has, the more likely her choices will enhance her own and her children's safety when dealing with intimate partner violence Consejo's Domestic Violence Program provides one-on-one client advocacy where advocates work in partnership with the survivor to identify and address a wide variety of basic and emergent needs Our services include emergency assistance, obtaining emergency shelter, transportation and food during crises Some survivors need assistance accessing long-term, self-sufficiency resources, such as housing, medical services, ESL-classes or vocational training Consejo's Domestic Violence program also provides legal advocacy in Spanish Advocates provide cultural mediation and translation/interpretation as needed and to ensure the survivor's success during legal and civil actions such as obtaining a civil protection order, filing for dissolution, establishing paternity, setting up a parenting plan or custody order, obtaining child support or immigration assistance
