The State Alliance for the Reform of Chemical Policy (SAFER) is a coalition of state environmental health organizations working to phase out the use of highly toxic chemicals at the national level. SAFER provides networking, capacity building and communications support to participating organizations.

The Toxic-Free Legacy campaign works to phase out highly toxic chemicals used in commerce and replace them with safer substitutes. WTC publishes educational materials for the public and government officials, and develops policies to achieve its goals.

(Code) (Expenses \$ 88,847 including grants of \$) (Revenue \$)

Through the Research program, WTC conducts independent scientific research on the hazards of toxic chemicals found in consumer products and the environment and publishes its findings in in-house publications.

(Code) (Expenses \$ 103,197 including grants of \$) (Revenue \$)

WTC's other programs advance the organization's mission to protect public health and the environment by eliminating the use of toxic chemicals. WTC conducts original scientific research and publishes reports on the effects of toxic chemicals, provides consumer education on alternatives to household chemicals such as cleaning products, pesticides and herbicides, and advocates for the increased use of locally grown foods raised without chemical pesticides or fertilizers. WTC also founded and manages the Toxic Free Legacy Coalition, a statewide coalition of organizations concerned about public and environmental health that are committed to phasing out the use of highly toxic chemicals in Washington State.

The Executive Committee's primary purpose is to manage the Board and support the Executive Director. The Committee is empowered to act on behalf of the Board on urgent issues that cannot wait for a full Board meeting. All decisions and actions by the Executive Committee must be reviewed at the subsequent Board meeting.
