Advocacy - ADWAS has advocates on staff to assist people who are victims of domestic violence and/or sexual assault and need help. Services are free of charge and available to people who are Deaf, Deaf-Blind or Hard of Hearing and residents of King, Pierce or Snohomish County. During 2009, ADWAS served 266 women and children and provided outreach/education to 7,500 people. Counseling - The counseling program offers victims of domestic violence and sexual assault the following services: Short-term crisis counseling; On-going individual/family therapy related to domestic violence & sexual assault; Group counseling related to childhood sexual assault and domestic violence; Psychosocial assessments and evaluation of sexual abuse of children; Client advocacy and referrals.

Positive Parenting - The Positive Deaf Parenting program offers parenting education and support to all members of the Deaf community. ADWAS offers a variety of classes and workshops throughout the year in King County.

Housing and Community Building Programs - Completed second full year as landlord at A Place of Our Own, encountered many challenges that resulted in new policies/procedures as well as multiple learning experiences for the staff. This transitional housing facility is for low-income women and children who are victims of domestic violence. Began National Replication Project in the fall of 2008 through a grant from the Department of Justice. Actual training to take place starting in May 2009. Will conclude mid-2010.
