Client Services--Client services provided comprehensive case management for nearly 500 clients in 2009. This is a 25% increase from 2008. These services included: accessing medical and dental services, obtaining critical HIV medications, providing substance abuse counseling and providing treatment and referrals, contracting for mental health services, and, providing emergency housing services to keep clients from becoming homeless. PCAF, in collaboration with the Chicken Soup Brigade program, provides weekly for over 75 clients nutritious food which supplements their food stamp buying power. In addition, we have an Essential Needs bank (ENB) where clients can receive one bag per month of important sundry and household cleaning supplies. This includes items such as disinfectant cleaning agents, toothbrushes, shampoos, toilet paper, etc. This both stretches their dollars each month and also increases their ability to maintain a clean and healthier home.

Education and Prevention--Prevention services implement a wide-range of evidence-based prevention programs targeting high-risk population within Pierce County. This includes an evidence-based program called SISTA that reaches African American women ages 18-29, and a counseling model program that works with HIV+ state prison inmates scheduled for release from prison. The Oasis Youth Center, a program of Prevention Services, is a national model that provides an array of critical prevention programs for GLBT youth. These programs include HIV prevention, violence prevention and advocacy services, and tobacco prevention. Oasis has developed a youth-adult collaborative leadership model that is acknowledged as a model for other youth serving programs.
