

Changes in PlantAmnesty's fund balances (negative for 2009) are due to the one time production of the organization's public event 'Festival of Trees.' This two-day event involved hundreds of volunteers, paid contract performances and symposia on the local urban tree/shrub environment. Grants were received for a portion of the event (see Part III, Line 29) but it was a large scale event and, since it was free to the public, cost more to produce it than PlantAmnesty could recover. As such, no event is planning for 2010 and future plans for this event will bear that cost in mind.
