We lead the Washington Families Fund (WFF), a public-private partnership that makes grants to housing and service organizations that are serving homeless families in their communities Locally, we partnered with the Workforce Development Council of Seattle-King County to develop a Housing and Employment Navigator pilot designed to assist homeless families with employment services This year we awarded new grants to 8 new programs statewide and added 96 units of service-enriched housing for a total of 618 units We are taking aggressive steps to end family homelessness in King, Pierce, and Snohomish counties Beginning in 2010 we will be funding systems innovations grants focused on prevention, coordinated entry, rapid re-housing, tailored programs and economic opportunities
