The King County Library System Foundation creates opportunities to bring literacy, learning and library access to all members of our diverse community. The KCLS Foundation provides venture capital for library initiatives that address community needs, the funding for value-added programs and resources, and the vision to ensure that our public library system is vibrant, relevant and central to our lives. As sources of information multiply, it is vital that the library strives to reach all members of the community through services in the libraries, online and in our communities. Each year, nearly 150,000 children and adults participate in KCLS Foundation supported programs.

 Summer Reading Program-Be Creative @ the Library attracted 43,654 young readers and rewarded 23,754 readers for reaching their 1,000-minute goal. Pizza Hut generously supported the program, which helps kids maintain and enhance their reading skills during the summer. In addition to general support, the KCLS Foundation provided the funding for buses to bring thousands of summer school students to libraries for programs and activities.

 Read 3, Get 1 Free Program. For each set of three reviews, a teen selects a free book as a reward. For 2008-2009, 5805 teens read and reviewed 32,577 books and received 10,859 free books.

4c (Code) (Expenses \$ 31,840 including grants of \$ 20,000) (Revenue \$)
 The Big Read - The King County Library System was one of 208 communities nationwide participating in The Big Read. The featured book was The Call of the Wild by Jack London. The children's companion book for ages 10 and older was Hatchet by Gary Paulsen. The Big Read coincided with the county-wide anniversary celebration of the Alaska-Yukon-Pacific Exposition, held in 1909.

Fiestas de Alfabetization provides early literacy training to Spanish speaking parents. Fiestas involved 784 parents in the workshop series and 972 children participated in the programs. Ready, Set, Read! challenges kids to set goals and establish the reading habit. Eighteen school districts promote the program in elementary grades. In 2008-2009, the Foundation provided 10,067 books for students who completed their 400 minute goal.
