Delivering bibles and Christian literatures to the persecuted church in the Gospel restricted nations such as North Korea, China, some Islamic nations, and Israel with the combined effort of other partnering ministries and missionaries. We also have broadcasted one hour a day over short wave to reach believers and leaders in North Korea. We have delivered 262,077 bibles. Currently North Korean bible is being translated into their native language.

4b (Code _____) (Expenses \$ 189,220 including grants of \$ 126,884) (Revenue \$ _____)
Raise up leaders in the restricte nations for them to be ministers and to propogate the Gospel of Jesus Christ by having bible school, seminaries, and conferences along with other ministers and missionaries. Equip potential leaders among Koreans living in Korea and living abroad the world to enter into the restricted mission fields. Distribute newsletters and prayer letters to inform the needs of supporting leaders in the restricted nations. Total of 313 leaders were trained and 8,916 hours were spent by 35 teachers.

Facilitating and supporting other ministries and missionaries for networking and partnering in delivering and teaching the Word of God and train people to be missionaries in the restricted nations. Over 451 people were involved in varuous training and conference sessions including field trainings, and have supported 4 organizations and 4 individuals. Seven missionaries are in the field to work with the local pastors and ministers.
