Research, Issue Education and Outreach. NWFCO provided technical assistance, policy updates, and educational materials to health care and grassroots organizations across the country through the Health Rights Organizing Project website and listserve, regular conference calls, and in-person meetings. NWFCO also organized educational activities around the country to highlight racial disparities in health. NWFCO trained 200 grassroots leaders, organizational heads, and faith leaders to educate others on immigration and the immigration system, as well as distributing a board game and video to facilitate these conversations. NWFCO produced reports on: living wage and the job gap; Native health; racial disparities and health. Following their publication, provisions on Native health and health disparities were included in health/health care policy proposals. NWFCO also worked with Main Street Alliance to research and produce reports on small business health care issues and financial reform.

4b (Code:) (Expenses \$ 205,235 including grants of \$ 0) (Revenue \$ 30,625)

Skills Training & Organizing Assistance for Staff & Community Leaders. NWFCO held more than 30 trainings/workshops/educational forums attended by over 900 participants. Leaders and staff from more than 70 organizations nationwide participated in these trainings. They included skills trainings (public speaking, community organizing, etc.) and issue trainings on topics ranging from racial disparities in health to the causes of the recession. Events ranged from our Summer Leadership Conference, providing training and relationship-building for over 300 grassroots leaders from the region and the country, to webinars in which NWFCO trained organizers from 45 states on health equity issues. NWFCO supported national, state, and local organizing campaigns to increase access to health care, address racial disparities, advance economic equity, and support immigrant rights. NWFCO also worked to support the development of a national network of 11 small business organizations called Main Street Alliance. Staff went on site to train staff and leaders on outreach, public education and leadership development.

4c (Code:) (Expenses \$ 29,319 including grants of \$ 0) (Revenue \$ 1,200)

Organizational Development. NWFCO invested significant resources in developing our member organizations' and partners' management skills and technology. NWFCO organized three Executive Director meetings with member organizations, focusing on fundraising, development and review of annual plans. NWFCO held a financial management training for 27 administrative staff and board members from Seattle-based social justice organizations. In addition, NWFCO provided two trainings on board participation for board members in Oregon and Washington, as well as providing time management and supervision trainings. NWFCO also held one on one meetings with Executive Directors of immigrant organizations on an as-needed basis. These meetings included reviewing model Board of Director policies and staff management strategies. NWFCO also continued to invest in supporting the emerging small business organizations that are part of Main Street Alliance.
