Powerful Voices' juvenile justice program (aka STAGES) includes several FREE prevention and intervention services for 13-18 year old girls, typically, in or at great risk of entering the juvenile justice system In King County Juvenile Detention we offer in-detention health and wellness workshops and one-on-one referral support for over 100 girls annually In-detention staff creates a safe space for girls to gather and explore tools for assessing their situations and decision-making In Seattle, 35 girls may receive case management services for individual attention, youth violence prevention and academic support year-round We offer a year-round employment service for 24 girls ready to develop the skills they need to reach their goals Each girl receives a stipend and has a volunteer mentor for additional long-term support In 2009, an additional 40 girls participated in a group at a Renton alternative public school

Powerful Voices' middle school program (aka Girls RAPI) offers several FREE youth development services for 10-14 year old girls The program serves approximately 190 participants each year in five Seattle public middle schools In three middle schools the girls participate in after-school groups and one-on-one mentoring In two middle schools, girls participate in weekly all-girl health class and ongoing one-on-one referral support Girls have an opportunity to make connections between their rights, their potential for activism and the resulting power they experience as a group working together in their school community Time in the group builds respect among girls, an inclination toward activism, use of critical thinking skills and individual self-expression Girls engage in an exploration of girlhood and help clarify the values they hold In the summer girls may participate in an intensive leadership and youth development day camp
