RENEWABLE NORTHWEST PROJECT WORKS TO INCREASE THE DEVELOPMENT AND USE OF RENEWABLE ENERGY RESOURCES THROUGHOUT THE NORTHWEST AS A MEANS TO PROVIDE BOTH ENVIRONMENTAL AND ECONOMIC BENEFITS FOR CITIZENS.

OVER 1,200 MEGAWATTS (MW) OF NEW, RENEWABLE ENERGY PROJECTS IN THE NORTHWEST CAME ON-LINE DURING 2009. THIS CONSTITUTES A 58% INCREASE IN THE AMOUNT OF RENEWABLE ENERGY CAPACITY IN THE REGION OVER THE PREVIOUS YEAR. THE NORTHWEST IS NOW HOME TO MORE THAN 4,100 MW OF WIND, SOLAR AND GEOTHERMAL PROJECTS, ENOUGH TO POWER ABOUT 1,036,000 HOMES.
