

Achievements

28) Medical Training & Development through International Exchange:

MEDRIX and 10 Seattle Pacific University nursing students partnered with 10 Hue Medical and Pharmacy School of Nursing students and Hue Central Hospital for an International Education and Training program in Pediatric Clinical Training and Community Health in Vietnam. The participants taught in 1 pediatric hospital, 1 community hospital, 4 village health clinics, pre- and elementary schools, middle school and participated in home visits. Over 500 Vietnamese women received education in personal health & hygiene, environmental health, and cleanliness during pregnancy from the Seattle Pacific University nursing students.

MEDRIX Total Expenditure: \$ 51,436

29) Medical Training through Integrated Management of Childhood Illnesses (IMCI)

MEDRIX provided IMCI training for 44 doctors, nurses, and midwives in Central Vietnam. The program seeks to improve health, specifically with children, in communities throughout Vietnam through this training. The attendees learn to detect childhood illnesses at earlier stages and therefore improve the health of the children in their respective communities.

Foreign Grants: \$ 8,933

MEDRIX Total Expenditures: \$ 13,200

30) Safe Water Development

MEDRIX collaborated with Health Service Department in Vietnam, PCERWASS, and other governmental agencies for the successful placement of approximately 30 Ultraviolet water systems. These systems will give 800 children and teachers in Vietnam safe water access every day at their respective schools. In addition to these installed systems, MEDRIX maintains the Ultraviolet water systems that have been installed in years prior to 2009.

Foreign Grants: \$ 1,532

MEDRIX Total Expenditures: \$ 11,819

31) Other Program Services

Summary of Objectives & Accomplishments:

- MEDRIX supported 30 doctors and nurses in an advanced course in English Medical Terminology to increase their communication and training potential within the international medical community. Services were provided in partnership with Health Service Department of Thua Thien Hue Province and PCERWASS.

- MEDRIX provided a refuse system in 3 communities in the Nam Dong District of Vietnam. These systems contained dumpsters and garbage bins for waste. This project improves the overall community health and hygiene in the region.
- MEDRIX evaluated and funded four heart surgeries for Vietnamese children that will extend each of their lives. (Foreign Grants: \$2,820)
- MEDRIX provided 100kgs of chloramines B to treat the water in rural areas near Hue, Vietnam after Typhoon Ketsana destroyed and contaminated water sources. This reduced the potential of epidemics, which are common after typhoons and flooding.
- MEDRIX partnered with an engineer student that spent 2.5 month in Vietnam testing the use of a solar-powered battery to operate the MEDRIX UV Water Treatment System.
- MEDRIX funded grants for various medical cases including: preventative medical training, midwifery training, and a leukemia patient (Foreign grants: \$540)

Total Other Program Services Expenditures: \$ 111,476
