Christian Community Home of Hudson, Inc is an 81-bed nursing home and a 37-unit assisted living housing facility, and provides long term and assisted living services to the elderly and disabled The organization's nursing home provides long term care services for the aged and disabled members of the community Health care services to medicaid nursing home residents, are considered part of the organization's benefit provided to the community, since a substantial portion of such services are reimbursed at amounts less than the costs of providing care For 2009, total nursing home resident days were 27,720 Included in this total was 11,054 days for residents covered under the Medicaid program The nursing home offers skilled nursing care in both short-term rehabilitation programs and long-term care resident programs Some of the specialized care services offered include IV therapy care, wound care, pain management, physical therapy, occupational therapy, and speech therapy among many of the care programs provided Christian Community Homes of Hudson, Inc provides assisted living services through Pine Ridge, a Community Based Residential Facilities (CBRF) This facility combines independent living with the convenience of monitored assisted living care plans to offer residents the option of living independently while at the same time having the comfort of knowing that additional care is available as needed Services offered at Pine Ridge include housekeeping, laundry, nursing assistance with activities of daily living, dietary services, medication management, and other nursing supervision and care services Total resident days for 2009 at Pine Ridge were 10,856

Wintergreen Apartments, Inc is a 92-unit apartment complex, which provides independent and assisted living for senior adults Among the many services provided are 24-hour on-site staff, assistance with medications, monthly or weekly vital checks, quarterly and annual nursing assessments, transportation services, and assistance with daily cares Total resident days at Wintergreen Apartments for 2009 were 28,613
