Form 990: Part VI, Section B, #11A: WestSide Baby has an employed Financial Manager who is responsible for oversight of all donations and expenses that pass through WestSide Baby. Both are tracked using Quickbooks and Classes. Profit and Loss reports provide the basis for preparation of the Form 990. The return is initially prepared by our Financial Manager, reviewed in detail by the Executive Director and Board Treasurer and Finance Committee and reviewed by an independent accountant. The return is presented to the Board for review prior to filing.

Form 990: Part VI, Section BB, #12C: WestSide Baby has a conflict of interest policy that is reviewed and signed by the Board of Directors on an annual basis.

Form 990: Part VI, Section B, #15: The Executive Director was originally hired in November 2006 to replace the Founding Executive Director who operated WestSide Baby for its first 5 years as a volunteer. At that time, the Board of Directors consulted the United Way of King County's salary guide for Executive Directors and determined a range within comparable children's charities with similar income. The salary was offered below that range as the candidate did not have extensive employment history as an Executive Director. As this hiring process would increase the hours worked for the position from 12 per week to 20, and then eventually 30, the salary was increased in direct proportion to the increased hours. In December 2007, the Board voted to award a small bonus and a small raise was presented. No salary increases were made in 2008 due to agency choice to prioritize the provision of services during the economic downturn. The salary is currently below that of similarly situated Executive Directors because of prioritizing programming. The process included a review and approval by independent persons, comparability data and contemporaneous substantiation of the deliberation and decision.
