- ☐ 2b. Proof of Name Change. If your name or the original enrollee/descendants name has been legally changed from that indicated on the birth certificate/s please provide appropriate documentation. (e.g. marriage and/or divorce certificates, adoption decrees )
- ☐ 3. Letter of reference. Letters of reference are valid for three years and must include a signature, date and contact information.
- ☐ 4. Official Grade Transcripts and/or Certificates of Completion. A copy of your final and official grade transcripts or certificates of completion for the most recent schooling that you have had (*when available.*) *Note: Official grade transcripts are signed by the school's registrar and/or have an official seal from the school.*
- ☐ 5. Statement of Purpose. Approximately 500 words on a separate sheet of paper. Your statement of purpose is important and evaluated carefully by the Education Awards Committee according to the following categories: clarity of goals, correct use of English language, relationship to community, and overall quality
- **First time applicants** – Describe your education and career goals. How are you currently, or plan to, contribute to a positive Alaska Native community? Explain your reasons for these goals and how your degree program fits with your education and career plans. You may include your personal history and a summary of accomplishments.
  - **Repeat applicants** – Update your education and career goals. How are you currently, or plan to, contribute to a positive Alaska Native community? What changes have might have occurred since your last application and why?
- ☐ 6. Proof of enrollment. Scholarship applicants must submit a copy of the letter of acceptance into an associate, bachelor, or graduate degree program **and** proof of registration for the term (i.e. class schedule.) If undeclared, the applicant must indicate the same in their Education Plans.
- ☐ 7. Photograph (optional). If you submit a photo, please enclose a signed Photo Release form. Please note that your photograph becomes the property of TCF and may be used in print and electronic TCF Publications. **SCHOLARSHIP PROGRAM ELIGIBILITY**

The CIRI Foundation Scholarship program is open to original enrollees of CIRI and the direct lineal descendants (either natural-born or legally adopted) of original enrollees of CIRI. Individuals who have inherited or received gifted shares do not qualify as original enrollees. All scholarships are made subject to available funding and up to the amounts listed below

**Scholarship applicants are:**

- **Students accepted or enrolled full-time in a degree-seeking program at an accredited or recognized institution. Full-time enrollment is taking at least twelve (12) undergraduate credit hours, nine (9) graduate credit hours during a semester/term/quarter, or as defined by your institution.**

*If you are enrolled in a certificate program or part-time in a degree-seeking program, please see the Grant Program Eligibility and deadlines (next page)*

**GENERAL SEMESTER SCHOLARSHIPS**

**Purpose:** Merit scholarships for applicants with academic promise.

**Requirements:** Must be accepted or enrolled full-time in either a 2-year or a 4-year undergraduate or graduate degree program. Applicants should have a cumulative 2.5 GPA or better.

**Amount:** Up to \$2,500 per semester

**Duration:** One semester. A student may receive no more than two (2) general semester scholarships during the academic year.

**Deadlines:** June 1 for the Fall term and December 1 for the Winter/Spring term

**ACHIEVEMENT ANNUAL SCHOLARSHIPS**

**Purpose:** Merit scholarships for applicants with exceptional academic promise.

**Requirements:** Must be accepted or enrolled full-time in a 4-year undergraduate degree or graduate degree program. Applicants must have a cumulative 3.0 GPA or better to be considered.

**Amount:** Up to \$8,000

**Duration:** One academic year

**Deadline:** June 1, only

**EXCELLENCE ANNUAL SCHOLARSHIPS**

**Purpose:** Merit scholarships for outstanding academic and community service experience.

**Requirements:** Must be accepted or enrolled full-time in a 4-year undergraduate degree or graduate degree program. Applicants must have a cumulative 3.5 GPA or better to be considered.

**Amount:** Up to \$10,000

**Duration:** One academic year

**Deadline:** June 1, only

**SPECIAL EXCELLENCE ANNUAL SCHOLARSHIP**

**Purpose:** Merit scholarship for exceptional academic and community service experience.

**Requirements:** Must be accepted or enrolled full-time in a 4-year undergraduate or graduate degree program. Applicants must have a cumulative 3.7 GPA or better. Preference is given to the fields of business, education, math, sciences, health services, and engineering. *This award is made at the discretion of the Education Awards Committee.*

**Amount:** Up to \$20,000

**Duration:** One academic year

**Deadline:** June 1, only

**DEADLINES**

Applications must be received by The CIRI Foundation on or before the deadline to receive consideration. Late applications will not be considered. The stated deadline remains in effect whether the day falls on a weekend or a holiday. Please submit an application **before** the start date of your coursework. Courses completed prior the application deadline are not eligible for funding. When we receive more applications than the available funding, meeting the minimum selection criteria does not guarantee funding at any level. Applicants are considered for the appropriate award categories based on the information provided in their application.

**SCHOLARSHIP AWARD USES**

Scholarship funds are for the direct educational expenses including tuition, student registration fees, course-required books/supplies, and on-campus housing/meal plans. Only if funds remain after the direct educational expenses are met, then up to \$500 per scholarship award may be released to the student for personal expenses.

#### Grant applicants are:

- **Students enrolled part-time in degree-seeking program taking 11 or fewer undergraduate credit hours or 8 or fewer graduate credit hours during a semester/term/quarter at an accredited or recognized institution <<OR>>**
- **Students enrolled part-time or full-time in a vocational training or technical skills program at an accredited or recognized institution for which a certificate of completion is earned.**

*If you are currently enrolled full-time in a degree-seeking program, please see the Scholarship Program Eligibility and deadlines (previous page).*

### VOCATIONAL TRAINING GRANTS

**Purpose:** To promote preparation for successful careers in a specialized technical skills field

**Eligibility:** Must be accepted or enrolled part- or full-time in a technical skills certificate or vocational training program. Should have a high school diploma or GED, must maintain at least a 2.5 grade point average; and must be prepared to demonstrate the availability of employment upon completion of the training

**Amount:** Up to \$4,500 received during a calendar year

**Duration:** May re-apply each quarter of a calendar year until the grant cap is reached. May re-apply the following calendar year after grant cap has been reached.

**Deadlines:** March 31, June 30, September 30, December 1

### CAREER UPGRADE GRANTS

**Purpose:** To encourage employment skills upgrades or re-entry into the job market to achieve improved job status through promotion or success in securing employment.

**Eligibility:** Must be accepted or enrolled part-time in a course of study that directly contributes toward potential employment or employment upgrade. Total credit hours must be 11 or fewer undergraduate credit hours or 8 or fewer graduate credit hours. Should have a high school diploma or GED; must maintain at least a 2.5 grade point average.

**Amount:** Up to \$4,500 received during a calendar year.

**Duration:** May re-apply each quarter of a calendar year until the grant cap is reached. May re-apply the following calendar year after grant cap has been reached

**Deadlines:** March 31, June 30, September 30, December 1

### DEADLINES

Applications must be received by The CIRI Foundation on or before the deadline to receive consideration. Late applications will not be considered. The stated deadline remains in effect whether the day falls on a weekend or a holiday. Please submit an application at the deadline **before** the start date of your coursework. Courses completed prior to the application deadline are not eligible for funding. When we receive more applications than available funding, meeting the minimum selection criteria does not guarantee funding at any level. Applicants are considered for the appropriate award categories based on the information provided in their application.

### GRANT AWARD USES

Grant funds are for the direct educational expenses including tuition, student registration fees, course-required books/supplies, and on-campus housing/meal plans for students who must live away from their permanent home in order to attend college. Only if funds remain after the direct educational expenses are met, then up to \$500 per calendar year may be released to the student for personal expenses.

The annual scholarship awards are highly competitive and meeting the GPA requirement is only part of the selection process. Other factors considered in the selection of annual scholarship awards include an exceptional statement of purpose with a clear articulation of education and career goals, a high level of community service and civic activities, and a demonstrated intent to give back to community and Alaska.

### NOTIFICATION OF FUNDING DECISIONS

The CIRI Foundation's Education Awards Committee makes the award selections and all decisions are final. All funding decisions are released in writing. Results are not released over the telephone or in person. Students are sent an award letter that contains important details regarding the terms and responsibilities of the recipient. It is essential that award recipients read and understand fully the terms of their financial aid.

### INFRACTION PROVISION POLICY

Award recipients are required to complete all courses and credits for which they are funded, and maintain a cumulative GPA of 2.5 or higher on a 4.0 grading scale. Failure to meet the terms of an award may jeopardize an applicant's future eligibility. Except in cases of special circumstances, recipients who infract will be ineligible to apply to The CIRI Foundation for two (2) award deadlines from the date of determination.

### CONDITIONAL AWARDS

If you receive a conditional scholarship, grant, or fellowship award, you have thirty (30) days from the date on the conditional award letter to fulfill the award requirements. Funds will be released only if the requested information is provided to The CIRI Foundation by the conditional award deadline. If an application remains incomplete after the conditional award deadline, the award is automatically canceled.

### DISBURSEMENT OF FUNDS

Award checks are made payable to both the student and the university/school, and must be endorsed by both parties to be processed. Award checks are sent directly to the financial aid office at the institution specified on your application. Students are sent a photocopy of the disbursement letter that accompanies the award check. To avoid unnecessary delay in the receipt of your financial aid, please provide accurate payment information on your application. If your educational program requires a different payment procedure (ie payable to school only, online program), please indicate on the application (line #13).

### PROOF OF COMPLETION

Scholarship and grant recipients must submit final official grade transcripts or certificates upon the completion of each semester/term of funding. Proof of completion must be received before any additional funds will be released or future applications can be considered.

### NUMBER OF AWARDS

While there are several Foundation scholarship and education grant programs, an applicant is permitted to receive only one (1) award at a time and no more than two (2) semester scholarship awards per academic year or the maximum amount of grant funding in a calendar year.

**Amount:** \$2,000 maximum based on stated need.

**Duration:** One semester only.

**Deadlines:** June 1 and December 1

**JOHN N. COLBERG ENDOWMENT SCHOLARSHIP FUND**

Established in memoriam by CIRI, Sally Berlin and Frank Saracoff, Peter and Evelyn Hocson, and Robert and Kathy Woodhead to encourage students pursuing the study of law.

**Eligibility:** Preference for undergraduate degree or graduate degree students enrolled in the study of law. Should have a cumulative 2.5 GPA or better.

Established by Howard Keck and Westmin, Ltd. to encourage undergraduate or graduate students in all fields.

Marrs in 2001 to encourage students seeking an undergraduate or graduate degree in business administration, economics, finance, organizational management, accounting or similar fields. **Special features:** The Fellowship is for organizational management courses of study, internships or specialized or general management or organizational training programs.

**Deadlines:** June 1 or December 1

**Duration:** One semester. Must re-apply each semester.

**Deadline:** June 1 and December 1 for scholarships, June 30 for grants

#### **SALAMATOF NATIVE ASSOCIATION, INC. (SNAI) SCHOLARSHIP PROGRAM**

Established in 1992 by the Salamatof Native Association, Inc. to offer merit scholarships.

**Eligibility:** Original enrollees of SNAI, their direct lineal descendants, and spouses. Must be accepted or enrolled full-time in an undergraduate or graduate degree program or technical skills training program. For tuition, required fees, books, on-campus-related room, and meal plan and for other direct school related costs. Should have a cumulative 2.5 grade point average or better.

**Duration:** Annual. Applicants apply only one time during the year.

**Deadline:** June 1, only

#### **TYONEK NATIVE CORPORATION SCHOLARSHIP (TNC/NVT) AND GRANT PROGRAM**

Established by the Tyonek Native Corporation in 1989 to encourage professional preparation for careers after high school.

**Eligibility:** Original enrollees of TNC, their direct lineal descendants, and tribal members of the Native Village of Tyonek (NVT). Must be accepted or enrolled full-time in an accredited or otherwise approved post-secondary college, university, or technical skills education program. Must have a cumulative 2.0 grade point average or better.

**Duration:** Scholarship applicants must re-apply each semester. Grant applicants may re-apply each deadline of a calendar year until the funding cap is reached and may re-apply the following calendar year after grant cap has been reached.

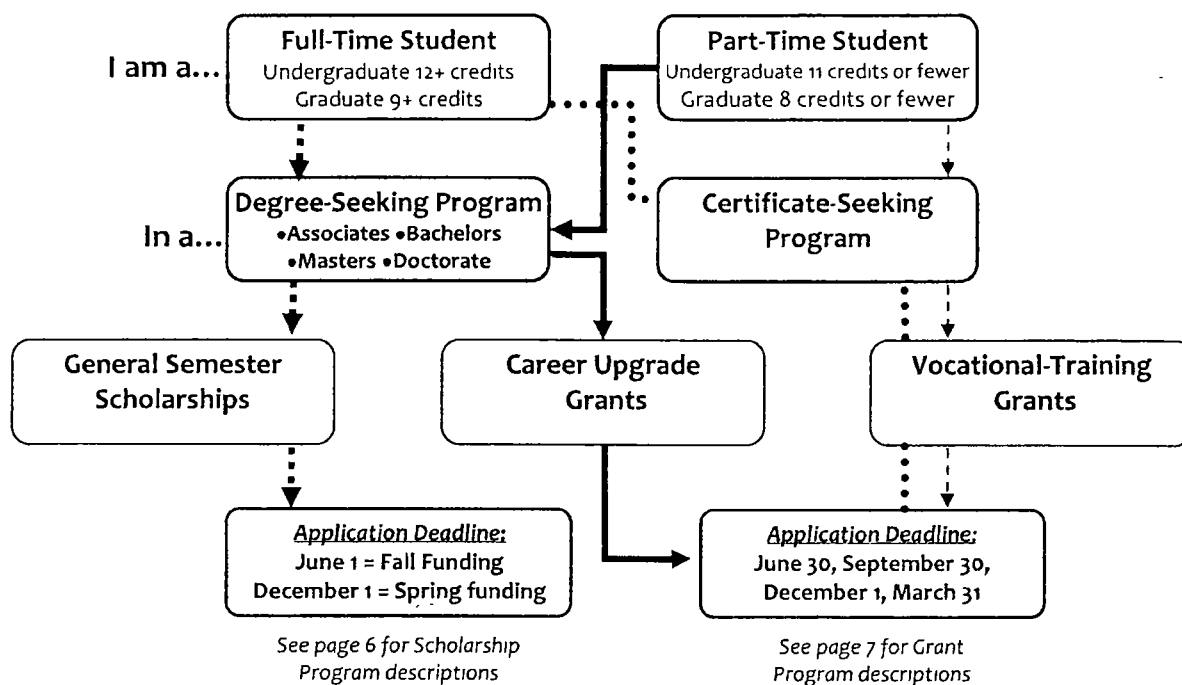

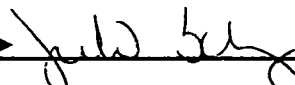
