



**The following amended articles are intended to substitute for and replace all previous articles of the HEARTREACH PREGNANCY CENTER. In addition to the designated amendments, these restated articles correctly set out the provisions of the articles that will remain the same.**

The result of the adoption of these amended and restated articles, as evidenced by the signatures entered below, is that this document will be considered the operative articles of the corporation in place of any and all articles that preceded these restated articles. The undersigned, being all of the directors of the corporation and all being over nineteen years of age and being citizens of the United States who are residing in the State of Alaska, desiring to amend the existing articles of incorporation for HEARTREACH PREGNANCY CENTER in accordance with Chapter 20, Title 10, of the laws of the State of Alaska, do hereby certify:

**ARTICLE I - NAME AND DURATION (AMENDED)**

The name of this corporation is amended to be **HeartReach Center, Inc.** and the duration of the existence of this corporation shall be perpetual.

### **LIMITATIONS ON PURPOSES**

The corporation shall not have or issue shares of stock. The corporation is not organized for profit. No part of its net earnings will inure to the benefit of any member, director, or individual member. The balance, if any, of all money received by the corporation from its operations, after the payment of all debts and obligations, shall be
