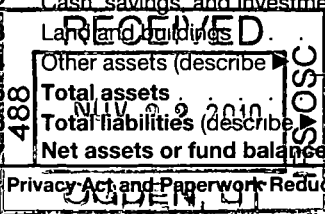

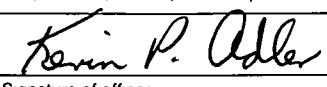

Primary Purpose: Fraternal Benefit Society
