In 2009 we offered over 160 programs for people all ages and had over 4,075 people participate.

The Pratt Museum's exhibits bring our mission to over 35,000 visitors each year by showcasing and providing interactive learning experiences around the art, natural history, and human experience of the region. Approximately six rotating exhibits on a variety of topics are offered each year in the museum's special exhibits gallery.
