Part VI, Line 7a - The one class of members all have one vote per member to elect directors, vote on changes to the cooperative's articles or bylaws, and any other action that needs approval of the general membership.

The voting requirements are as follows: ten percent of the members need to vote on the matter to represent a quorum, no proxy votes, and a two-thirds affirmative vote is required to approve the action.

Part VI, Line 11 - The Form 990 is prepared by staff. Once the form is prepared it is sent to company's attorney and auditor for review. After it is reviewed it is presented, unsigned, to the board of directors for review at a board meeting prior to filing.

Part VI, Line 12c - The cooperative reviews compliance statements, contracts, and transactions for conflicts of interest as part of our regular course of business.

Part VI, Line 15a - The board of directors fill out evaluation forms on the General Manager annually. They annually do a survey of Oregon electric co-ops regarding general manager salaries and compensation. They then have a formula that they apply to the results to assist in their determination of the GM's compensation.

Part VI, Line 15b - The General Manager annually does a survey of 16 electric utilities in the northwest of comparable size for management staff. The GM then evaluates results with compensation given to GM by the board and compensation that supervised staff is getting from their wage & salary program to determine compensation for management staff.

Part VI, Line 19 - Unaudited financial statements are mailed to all members prior to our annual meeting and are available on our website. Audited financial statements, bylaws, board policies, and other organizational documents are available upon request.
