FOOD Aid

Re-distribute donated, purchased & government-provided food to individuals & families in need. Clients may obtain food once every 4 weeks though some exceptions allow for more frequency. In 2009 FISH provided additional food at Christmas for 336 families (268 in 2008, 192 in 2007) In 2009 FISH provided food vouchers for additional Thanksgiving food to 353 families (251 in 2008) In addition we coordinated with other local organizations to allow them to sponsor 44 families at Thanksgiving and again at Christmas.

DENTAL and PRESCRIPTION Aid

FISH pays a portion or all of a client's necessary medical prescriptions infrequently and on a limited basis and also pays some emergency dental work when clients lack the funds to pay. Payment is in the form of a voucher. FISH is billed by the pharmacy or dentist.

MOTEL Lodging
