Black United Fund of Oregon is a non-profit corporation that is an independent fundraising, philanthropic and community development organization. Its mission is to assist in the social and economic development of Oregon's disadvantaged communities.

Community Development/Philanthropy - Under this program Black United Fund partners with neighborhood organizations and residents to initiate community problem solving efforts that identify unmet social and economic development needs in Oregon's low-income communities. These issues are addressed through a wide range of collaborative programs that include the areas of healthcare, education, economic development, and neighborhood revitalization. Through educational and outreach initiatives, Black United Fund increases awareness to social, economic, and cultural significance of philanthropy, builds the capacity of individuals to give, and encourages greater philanthropic awareness. People benefited from grants and allocations to other agencies. Long-term goals include the establishment of a multipurpose cultural and educational institution that will highlight the culture, history and contributions of African-Americans, and provide space for small nonprofits and small business owners. During the year ended December 31, 2009, 71,592 people benefitted from grants and allocations; 176 benefitted from non-profit workshops; and 59 agencies received grants.

Education & Training - Under this program, Black United Fund provides professional training to community based organizations in the areas of non-profit management board development, social issues, organizational efficiency and skill and leadership development. Black United Fund also operates a non-profit resource library and computer resource center for the use by non-profit groups, provides support to non-profit organizations whose mission enhances cultural diversity, serves as an educational resource to youth, and partners with local colleges and universities to provide college scholarships to African and Black high school seniors in Oregon. During the year ended December 31, 2009, Black United Fund provided 21 scholarships and 42 participated Path to Scholarship workshops.
