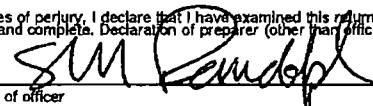
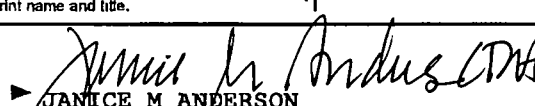

The Makindu Children's Program (MCP) and Makindu Children's Center (MCC) have a unique relationship and history. Starting in 1998 U.S. based organization operating the Center in Kenya, two distinct organizations have evolved: the independent Kenya organization responsible for all program management and operation, and the founding and former parent organization that now acts as a U.S. based funding arm. Makindu Children's Program was granted non-profit status in 2000 and continued to operate MCC in Kenya. In 2001, MCC became a Kenyan NGO (non-governmental organization) with guidance, management, and funding continuing via MCP in the US and Kenya. During the next four years MCP board and staff worked to foster local "ownership" of MCC. A local Kenyan Advisory Committee was formed to provide local oversight and to guide the program through community input and direction.

In 2005, the MCP Board of Directors passed a resolution giving the MCC Committee greater authority in the day-to-day management of the Center. By 2008 MCC was essentially independent and the new MCC Constitution was amended and approved with the Committee becoming the MCC Local Board of Directors.

The MCC's evolution to independence and local control is important because they are now able to secure international grants which MCP would not be eligible for. Currently MCP provides approximately 1/3 of the Center's budget. This crucial core funding has acted as a leverage point and allowed MCC to secure further funding from the USAID program PEPFAR, an international foundation and the Kenyan government. These funds helped MCC increase enrollment from 125 to over 400 in a three year stretch.

Every year 2-4 MCP board members travel to Kenya at their own expense to provide volunteer support and programmatic advice. These visits also provide important opportunities for maintaining a strong relationship and review of fiscal and management processes.

All MCP board members are volunteers and are actively engaged in fundraising, marketing and consulting with MCC on administration and operations when requested.
