	Youth Grow Program The Youth Grow Program nurtures the next generation of veggie eaters and veggie growers through after-school garden clubs at low income neighborhood schools. These year-round programs include a special summer garden camp focus as well as weekly clubs throughout the school year. In 2009, we increased learning hours in Garden Club to 5,024 hours, reaching 320 children after school. 82 children and 45 adults participated in summer Parent/Child Gardening Workshops. 28 volunteers dedicated 644 hours working directly with Garden club students, and 32 people graduated from School Garden Coordinator Certificate Training.

	Home Garden Program	The Home Garden Program gets at the root of hunger by building home food gardens for low income households. Staff and volunteers provide support to home gardeners for three years with seeds, plants, supplies, classes, mentors and more. In 2009, we installed 66 new home gardens, reaching 172 adults and 152 children. We also provided support to 109 gardeners in their 2nd and 3rd years with the program, reaching 160 adults and 111 children. We conducted soil tests and provided education about the dangers of lead contamination for 71 low-income households, and 338 community members attended our Learn & Grow workshops and Work-Learn Parties. 393 community volunteers served 1538 hours in support of the Home Gardens Program.
