KS Wild's Conservation Program is designed to fulfill the group's mission to protect and restore the biological diversity of the Klamath-Siskiyou region. This area, stretching roughly from Roseburg, Oregon in the north to Redding, California in the south, and from the Pacific coast to the Cascade crest, contains some of the most ecologically critical wildlands along the entire West coast of the U.S. Our focus is the more than 6 million acres of federal public lands in this region, administered by the National Forest Service and the Bureau of Land Management (BLM). The Conservation Program was created in response to a history of ecologically destructive land management practices, including widespread clearcutting of old-growth forests, road building, cattle grazing and suppression of natural fire regimes. The core of this effort is our Forest Watch program, which monitors every proposed federal land management project in our area of focus. We comment, appeal and litigate, when necessary, against projects that pose a threat to forest health and biological diversity. One of the main focal points of the Forest Watch program in 2009 was the effort to counteract destructive firefighting strategies and ecologically damaging post-fire salvage logging on northern California's Klamath and Shasta-Trinity National Forests.

KS Wild's Forest Watch work is primarily a defensive approach to wildlands conservation. A more proactive approach is embodied in a variety of local, regional and national Campaigns that join KS Wild with other groups and networks to address a range of issues, including protection of threatened and endangered species, achieving designated Wilderness status for roadless areas, and promoting sustainable strategies to reduce the threat of catastrophic wildfire in the wildlands/urban interface zone. Campaigns and networking enhance our impact and bring national attention to these issues. Among many other ongoing projects, a notable event of 2009 was KS Wild's launch of an organized campaign for a Siskiyou Crest National Monument. The Crest is a critical area of habitat connectivity in the Northwest, connecting the Coast Ranges to the Cascade/Sierra crest, and is home to a wide range of unique and endemic species. In addition to the Siskiyou Crest Campaign, 2009 saw the launch of the Rogue Riverkeeper program. RRK expands KS Wild's reach by working to protect and restore the aquatic habitat of the entire Rogue Basin in southwest Oregon, enforce the Clean Water Act, and educate the public about the importance of aquatic conservation in the Klamath-Siskiyou region, home to free-flowing rivers and some of the best wild fisheries in the U.S.

The third critical element of KS Wild's Conservation Program is Outreach. We work to educate the public about the value of intact, healthy ecosystems and the long-term ecological and economic consequences of federal land management practices, including timber sales, road construction, predator control, public lands grazing and recreational developments. In order to fulfill these goals we produce and distribute a quarterly print newsletter (3,500 copies per issue) and bimonthly email updates, lead hikes, show environmental films, and coordinate a variety of educational public events. KS Wild's growing membership, currently almost 1,800 paid members, has become a stronger voice for conservation and wise public lands stewardship. Our outreach efforts complement KS Wild's conservation advocacy by building a strong constituency for wildlands protection and restoration in the region.

**Form 990, Part III, Line 2:**

2009 saw the launch of the Rogue Riverkeeper program, a significant new aspect of KS Wild's program services. For ten years, KS Wild has been a leader in public lands and wildlife advocacy. Part of our success is based upon our readiness to strategically evaluate and adapt our approach to address the most pressing ecological issues. In 2008, we identified a big gap in aquatic advocacy; there was virtually no public oversight for Clean Water Act implementation and enforcement on the Rogue River. Public trust waters are among our most valuable natural resources, and the Clean Water Act's provisions for public involvement are critical to the effectiveness of this cornerstone environmental law. The Clean Water Act itself does not ensure clean water. The law depends on an informed, engaged public to speak up for clean water. In June 2008, the Waterkeeper Alliance, an international network of water advocates, approved KS Wild as the Rogue Riverkeeper. The program's initial emphasis is on Clean Water Act oversight, monitoring and restoration of abandoned mines, halting the construction of a Liquefied Natural Gas import facility on the Oregon coast and associated pipeline construction, and achieving permanent protection for the Rogue River through legislative action.
