Partnership for Safety and Justice unites those most affected by crime, violence and the criminal justice system to redirect policies and resources from an over-reliance on incarceration toward effective strategies that reduce crime and increase community safety.

Membership Engagement: The focus of our Membership Engagement program work is to position PSJ as a leader for facts and analysis on the need for reforming the criminal justice system and increase our member involvement in that reform. We make our research and analysis available to our membership through our news journal and action alerts, and to the general public through our website. Through Justice Matters, our news journal, we reached about 5,400 people each issue with news, issue analysis and resource information. In 2009, we covered topics such as Oregon's budget crisis and prison spending, taking a public health approach to drug addiction, and the crime drop in Oregon. We sent out 4 action alerts to approximately 1,100 members of our Action Alert Network encouraging them to become more involved in reforming the criminal justice system. Mid-year we launched a new website and had 14,000 visitors in 2009. The website continues to inform people about criminal justice issues.

4b (Code:) (Expenses \$ 125,030 including grants of \$ 0) (Revenue \$ 0)

Safety & Sentencing: Our Safety and Sentencing program develops approaches to public safety that more effectively build safe communities, are fiscally responsible, and reduce our reliance on incarceration. The program promotes safe and sensible sentencing reform as well as alternatives to incarceration. In 2009 we waged a concerted public education and outreach effort to help Oregonians recognize that a primary focus on prison building and incarceration is costly and ineffective, while investing in treatment and other prevention focused programs reduces future crime and saves tax dollars in the process. We reached out to a range of community and business organizations to make connections between their work and criminal justice issues. The coalition effort was rewarded by the passage of a landmark corrections savings bill in Oregon's 2009 legislative session (the Safety and Savings Act). The bill included a range of sentencing reforms that save roughly \$50 million in reduced need for prison beds and reinvested that money into critical public safety infrastructure like domestic violence services, addictions treatment, and community corrections. This organizing could offer a range of lessons for similar work across the country. We also began work on HEAL Oregon, to shift Oregon's approach to addiction toward public health and away from criminalization.

Crime Survivor Program: Our Crime Survivors for Community Safety program builds the voice of survivors of crime and violence to promote progressive responses to the needs of survivors, and support criminal justice reform that reduces future violence. In 2009 we conducted significant research for the preparation of a "Crime Survivors' Toolkit" that victim service providers and others can disseminate to adult survivors of crime. The "tools" will consist of comprehensive, easy to understand, culturally competent booklets that address a variety of victimization aspects and issues, including: Responses that People Commonly Experience After Crime, and How to Find Help in Your Community; and crime specific booklets including domestic violence, sexual assault, stalking, homicide and adult survivors of child abuse. This material will fill a gap in needed resources. It will be available in 2010 in written form and on our website. The goal is to reach at least 500 survivors in the first 18 months of distribution. In 2009, PSJ was a key organizer in a coalition effort of statewide victim service providers and advocacy organizations in a campaign to increase funding for the Oregon Domestic and Sexual Violence Services Fund. The ODSVS Fund provides vital resources to community based organizations addressing violence. We were successful in getting the fund increased.

0 Beyond Barriers: Our Beyond Barriers program works to eliminate the civil and social barriers formerly incarcerated people experience and helps create a society that better supports the successful re-entry and transition of people returning to the community from prison and jail. In 2009, we won a local campaign to change hiring policies and practices of the City of Eugene to make jobs more accessible to people with conviction histories. Stable employment is a key factor in reducing recidivism and we helped the city manager make the link between good public safety and reducing employment barriers for formerly incarcerated people.

0 Prison Program: The Prison Program continues our focus on people in prison and the conditions under which they are confined. The program advocates for increasing access to quality programs within prisons that strengthen rehabilitation, insuring that prisoners and their families have access to information on issues directly affecting incarcerated people, and preventing the implementation of policies or legislation that further erode the constitutional or human rights of prisoners. In 2009, we read over 2,500 pieces of mail from prisoners and sent out 2,000 prisoner packets to people incarcerated in Oregon's prisons. We made almost monthly visits, and we sent out 4 action alerts to inform and engage prisoners in criminal justice reform issues.
